#### **Diocesan Council**

What experience, gifts, and perspective can the nominee offer in the service of our Lord in this office?

I have been an active member of Good Shepherd in Allegan since moving from Virginia in 1979. Like most members of smaller parishes I have been involved in various aspects of our church, such as vestry member (Senior Warden, Clerk), choir, ECW,

outreach, fellowship, worship committee. For several years I selected all the hymns for Sunday services and I have been licensed to lead services, lay read, serve chalice, take communion to the sick and shut-in etc. Those of you who also attend smaller parishes understand that each person is both cook and bottle-washer as needed.

#### Please list the nominee's most recent PARISH LEVEL ministries and offices.

I served again as Senior Warden from 2017-2020, and have just been nominated for another term of three years on Vestry. Now I am on the Outreach, and Music and Worship Committees. I will be facilitating a class in dismantling racism (based on the Sacred Ground Curriculum) which we are calling "Embracing Diversity." Almost everyone in the parish is involved in the Allegan County Fair Good Shepherd food booth. We built our food booth inside the arts and crafts building over 50 years ago, and have been maintaining it every year, except 2020 - Covid year. As in past years I bake the nut pies (chocolate walnut and pecan) and serve three or more shifts to wait on customers. Y'all come!

As co-director of the Baby Closet, I write grants and grant reports, order supplies for the many layettes we provide for needy families in Allegan County, and so I have the pleasure of meeting these folks when they come to pick up the layette, diaper bag, car seat and pack n play (as needed).

I have been serving as a member of the Diocesan Council for three years. I am the liaison to the Council for Dismantling Racism in EDWM. I would be pleased to serve a second term.

As co-director of the Good Shepherd Baby Closet, I write grants and grant reports, order supplies for the many layettes we provide for needy families in Allegan County, and have the pleasure of meeting these folks when they come to pick up the layette, diaper bag, car seat and pack n play (as needed). Now, inspired by the good work St Luke's is doing, we are offering families in Allegan County one box of diapers each month for each of their babies. What a joy and privilege it is to serve in this way!

My studies (primarily through the diocesan workshops and classes from the Justice League), and work toward furthering the Beloved Community envisioned by our wonderful Presiding Bishop Curry has affected my teaching of English writing at WMU. My students study isms in our society that have disadvantaged particular groups of the society and develop a plan to create a more equitable society.

#### Please list the nominee's participation in anti-racism training(s), including the year.

I have been on the original task force group from EDWM (2018/19) as one of the representatives of the Southern Region since the formation of the group. We all attended a two-day workshop that was very valuable. The seven members in our Southern Region group studied the entire 20-week recommended course, Sacred Ground, in 2020 via zoom meetings. I will be conducting a training at Good Shepherd this Autumn. We are all eager to see more training take shape in the congregations of our joint diocese. I also have joined several National and Provincial zoom discussions on how to present, shape and enhance the Sacred Ground curriculum.
